GENERAL INFORMATION

AquiMax® Turf Lateral is a soil surfactant concentrate that enables precipitation and irrigation to penetrate through water-

resistant surfaces almost immediately.

Helps to decrease the amount of water lost to evaporation and surface run-off.

Regular use of **AquiMax® Turf Lateral** helps to reduce irrigation erosion and begins to rehabilitate poor draining, compacted soils that are susceptible to Localized Dry Spot (LDS).

DIRECTIONS FOR USE

NOTE: AquiMax® Turf Lateral is a soil water management system and is NOT effective on foliage.

When using low volume spray equipment and an over-the-top application, treatment must be immediately followed with a minimum ¼ inch of water to ensure soil contact.

Recommended for all turf grass areas including golf course tees, fairways, athletic fields, lawns, sod farms, and any other general use turf grass areas.

AquiMax® Turf Lateral treatments may be made approximately once a month.

The first treatment is made at a high use rate in order to properly surround the water repellent soil or thatch layers with surfactant.

Treatments that follow replace the surfactant lost over time due to normal degradation and biological activity under average conditions.

Treatments should start prior to or when signs of stress such as yellowing, curling leaves begin to show or as water is observed pooling on the surface.

The solution may be applied via an in-ground irrigation system, through a spray bar on a tractor or via hand-held sprayers.

AquiMax® Turf Lateral may be applied to bare ground, stressed or green plants if adequate water is used in the application.

Do not pre-mix with pesticides, nutrients or other adjuvants before mixing with water.

If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture and perform a phytotoxicity test to ensure crop safety.

USE RATES

First application: 4 to 8 ounces of **AquiMax® Turf Lateral** mixed in a minimum of 2 gallons of water for every 1000 square feet of turf or soil to be treated.

Second, third, fourth, etc. application: 2 to 8 ounces of **AquiMax® Turf Lateral** in a minimum of 2 gallons of water for every 1000 square feet of turf or soil that will be treated.

Applications should continue every 30 – 60 days or as needed.

STORAGE AND DISPOSAL

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

Disposal: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national and international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
