### FIRST AID

### GENERAL INFORMATION

**AquiMax® Turf Lateral DG** is a 100% active ingredient soil surfactant concentrate that enables precipitation and irrigation to penetrate through water resistant surfaces over time.

Helps to decrease the amount of water lost to evaporation and surface run-off.

Regular use of **AquiMax® Turf Lateral DG** helps to reduce irrigation erosion and begins to rehabilitate poor draining, compacted soils that are susceptible to Localized Dry Spot (LDS).

**AquiMax® Turf Lateral DG** is a water management tool that increases nutrient availability in the soil profile level where roots are actively growing.

Allows flexibility of application methods in areas where solution based treatments can be problematic such as slopes, slit seeding operations and rehabilitation of compacted turf with core aeration or to correct the water resistance than can result from native area maintenance burning.

Can be used as a seasonal residual wetting agent to reduce turf stress on sod farms,

athletic fields and golf courses and is also recommended for irrigation management when planting ornamentals or to follow a hydro-seeding operation.

### DIRECTIONS FOR USE

**AquiMax® Turf Lateral DG** is designed for use in standard spreaders.

The individual particles of **AquiMax® Turf Lateral DG** being spread are very light and should not be spread in windy conditions.

Check the spreader manual for instructions on how to calibrate and apply the recommended amounts below.

The application **MUST** reach the soil to be effective.

Only apply to dry plants and follow applications with watering within 24 hours to help the dry particles reach and penetrate the soil.

The first treatment is made at a high use rate in order to properly surround the water repellent soil or thatch layers with surfactant.

Treatments that follow replace the surfactant lost over time due to normal degradation and biological activity under average field conditions.

Treatments should start prior to or when signs of stress such as yellowing, curling leaves begin to show or as water is observed pooling on the surface.

If grass cutting is performed prior to irrigation or rain, do not remove clippings as much of the product may still be present.

### USE RATES

The first application of **AquiMax® Turf Lateral DG** should be applied at **4 - 6 pounds per 1000 square feet.**

Re-apply as needed to prevent yellowing/browning symptoms from re-appearing.

Though environmental conditions vary widely, **AquiMax® Turf Lateral DG** will generally need to be re-applied **every 1 or 2 months at 2 - 3 pounds per 1000 square feet.**

If the plants are showing signs of stress, re-applications should once again be applied at **4 - 6 pounds per 1000 square feet.**

### STORAGE AND DISPOSAL

**Storage:** Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

**Disposal:** Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national and international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations.
